I conditionally accept the "Eviction Notice" (Exhibit A) and "Writ of Assistance" (Exhibit B) documents regarding 372 Lewis Street from the Racine County Sheriff's Department and from the Racine County Judgement Clerk dated only as "July 2012" by badge number 6722 UPON THE CONDITIONS THAT ....

- 1. ...the Racine County District Attorney prosecutes the Racine County Clerk of Circuit Court who signed the "Writ of Assistance" (See Exhibit B as fully setforth herin) for certifying a false document by signing as a witness to a deceased judge, Dennis J Barry on a date many months after Judge Barry had died and that no judgment had been made in the case before his death.
- 2. ...The Racine County Sheriff's department describes what emergencies exist which allow such blatant disregard for the principles of law and specifically show how those circumstances apply to me, my property and this situation.
- 3. ...Gray and Associates return the promissory note to me.
- 4. ... the supreme court of Wisconsin explains to me how Five Racine County Sheriff's officers saying "I'll kick your ass if you don't do what I say!", and being pepper sprayed in the eyes, and tackeld, and being held in jail in extreme malfunctioning heat for days shouldn't make me concerned for my life in Racine

County. And if I'm concerned for my life in racine county how can I appear in any proceedings, how can I motion the court with unpopular positions when judges simply site contempt of court and have me hauled way? "An impossibility cannot be required" is a maxim of law therefore there cannot be any such civil court proceedings against me and my property in Racine County a hostile court where I cannot possibly have fair proceedings. Did I not ask Gray and Associates for a change of venue? Was I not entitled to a change of venue?

- 5. ...I'm shown evidence that I was served via the notary public address given to Gray and Associates in my conditional acceptance response to their "do you deny the debt" letter before the foreclosure proceedings even began? - 7. ...that the Racine County District Attorney prosecutes the Sheriff's Deputy #6772 for serving a defective notice without a date specified causing due process violations.
- 8. ...the Racine County Sheriff's department pay me 2
  Million dollars for conducting a sale of my home after
  being noticed by telephone in witness of a notary
  public before the alleged sale that...
  - a. An ongoing controversy continues regarding the property
  - b. I charge 2 Million dollars for the sale of my house without my permission.
  - c. I must be noticed at the address of Joseph William Baker % Marc Rassbach, Notary Public PO Box 39 Milwaukee 53201-0039
- 9. ... the Racine County Sheriff's department conduct an audit of the mortgages foreclosed on in Racine County over the last 5 years. To establish whether or not there was a clear chain of title showing whether the banks were entitled to the homes or not. A suggested vendor for the research is

10.... the Racine County Sheriff's department admits that

the courts are rigged to work on behalf of the banks.

11.... the Racine County Sheriff's department admits that bail bond signatures are gotten under threat, duress and coercion and are thus an invalid vehicle that the courts use to make money.

### CAUTION: DEFAULT TERMS BY NOT RESPONDING

The Racine County Sheriff's Department has 5 days to respond to these conditions if more time is needed for a serious reply then request more time in writing. If the Racine County Sheriff's Department fails to respond to the notary public in writing within the five days it shall be deemed/certified by the Notary that the Racine County Sheriff's department admits to the following:.

- The Racine County Government admits it is an organization which serves at the behest of the bankers and does not serve the men and women inside it's geographic boundaries.
- 2. The Racine County Government admits that it promotes the communist agenda to remove all property from private hands and gives control of properties to banks rather than to the individuals who had a vested and established right to live in the homes.
- 3. Racine County Sheriff's department admits that Judge Faye M Flancher did not consider the oral objections put forth by Joseph William Baker before Judge Dennis

- Barry. That the arguments put forward by Joseph William Baker were numerous, substantial and that they centered around core maxims of law which are self evident.
- 4. Racine County Sheriff's department certifies that the Clerk of the Court discarded Joseph's Objections for the record which were timely filed (see exhibit D as if fully setforth herein) denying Joseph access to the court. That the Clerk of the court would not return Joseph's numerous calls trying to schedule a hearing for the objections and a hearing for a motion to recuse Judge Faye M Flancher.

- 7. The Racine County Sheriff's Department admits that inmates and citizens are poisioned through the county's water supply by the addition of fluoride.

Fluoride makes it more difficult for individuals to grapple with cognitive matters of law, and brings on early dementia. The causing of exposure to sodium fluoride in water is an act worthy of sanctions.

- 8. The Racine County Government maintains two sets of financial records one which includes retirement funds and one which does not.
- 9. The Racine County Sheriff's department agrees that it shall impose upon itself a restraining order against it's officers, agents and assignees from being within a 500 yard distance of Joseph William Baker and/or Joseph's property at 372 Lewis Street near Burlington. - 15. Joseph William Baker has the right to protect his property, his liberty and his family with lethal force against false arrest, seizure, levy.
- 16. Racine County Sheriff's department admits that

  Mortgages cannot be enforced when they become bundled

  into securities when there are multiple owners under

  laws of equity the borrower has a right to have the

  mortgagor come to the court. This loan was

  "bifurcated" in this way as banks make money insuring

  bundles of loans and re-selling the loans.
- 17. In so much as it appears that intentional fraud is at work on the part of the banks, the county courts and the Sheriff's department. Damages accrued from the costs to persons evicted from their homes who were not tennants, but owners, having been forced to move, pay for storage, rents, living expenses, dining, entertainment, insurances, taxes, new houses, new vehicles etc... shall be reimbursed at a factor of 10

fold by the Racine County Sheriff's department based on cost estimates provided by Joseph William Baker.




